Planning with IRAs Under the "SECURE" Act – New Rules and Opportunities: The "Setting Every Community Up for Retirement Enhancement (SECURE) Act" of 2019 is now law and as such, has brought significant changes to the IRA minimum distribution rules and eliminates the stretch IRA for many beneficiaries.
